INSTRUCTIONS

1. Find a suitable place where the 7KW charger will be mounted? Even though the charger is IP65 rated it is best to leave under cover out of the weather. Preferably near switch board of the building as the 32amp rated cable will need to be ran to the socket.
2. Mount the bracket in a suitable location above the ground so the EV Cable can loop around the hook and then easily reach the EV when charging.
3. Organise an qualified electrician to wire and fit the 32Amp socket (P/n: EVC7KW-SKT).
4. Plug the 32Amp plug into the 7KW charger and the 32Amp socket and turn on the circuit breakers.
5. The 7KW charger (P/n: EVC7KW not included) should now be on and should be ready to charge.
